SUPERVISED CONTACT VISITS

The supervised time program is convened on Saturdays and alternate Sundays at times to be negotiated.

Usually six visits are offered on a fortnightly basis for no more than 90 minutes on each occasion.

For pre-school aged children we may alternatively be able to convene visits on Mondays and/or Fridays.

The monitored playgroup program is for children aged 5 years and younger and is convened on alternate Saturdays for a period of 90 minutes

Children's Contact Services Schedule of Fees

FEE TYPE	AMOUNT
Intake fee for Supervised Contact Visits only	Once off fee payable at Intake \$20.00 (\$10.00 concession*) Fee applies to each adult using the service and is non-refundable.
Subscription fee for Supervised Contact Visits	\$120.00 (\$60.00 concession*) for up to 6 visits, payable in advance. Fee applies to each adult using the service and is non-refundable.
Subscription fee for 'Kids Connect' Playgroup	\$60.00 (\$30.00 concession*) for up to 6 visits, payable in advance. Fee applies to each adult using the service and is non-refundable.
Quarterly Subscription fee for Change Over service	\$100.00 (\$50.00 concession*) per quarter, payable in advance. Fee applies to each adult using the service and is non-refundable. Note: Fees cover costs for use of all Children's Contact Service sites of Relationships Australia SA Ltd.
Court Report- Standard Report requested through Solicitor (client without Legal Aid funding) or unrepresented clients	\$110.00 per page (\$55 per page concession*)
Standard Report requested (Client with Legal Aid funding)	\$330.00 (up to 6 pages) \$550.00 (Over 6 pages) capped
Preparation of Subpoenaed Files	\$200.00
